2024-8 Capital Equipment Reserve

Whereas, The Board of the Village of Sloan has determined that a capital reserve fund be established for the future purchase of Public Works and Fire Department equipment and facility improvements; and

Whereas, General Municipal Law §6-c and §6-d allows for establishment of said reserve by resolution of the Board; Now, therefore be it

Resolved, that the Board is hereby authorized and directed to establish a capital reserve fund (the "Fund") pursuant to General Municipal Law; the Fund shall be known as the "Capital Reserve Fund" of the Village; the Fund shall be established for the purpose of funding the acquisition, construction, reconstruction, expansion, renovation, alteration and improvement of Village buildings, facilities, grounds and real property, including the acquisition of furnishings, equipment, machinery and apparatus required in connection therewith; and be it further Resolved, that the amount of the Fund shall not be greater than \$1,000,000 plus interest earned thereon; the term of the Fund shall not exceed ten (10) years; and the source of the monies for the Fund shall be derived from (a) amounts applied from budgetary appropriations of the Village from time to time (b) amounts from the unappropriated fund balance of the Village as directed by the Board from time to time, and (c) such other sources as the Board may direct, all as permitted by law; and be it further

Resolved, that the Capital Reserve Fund will be initially established with \$50,000.00 of unappropriated fund balance, effective August 8, 2023.
